POSITION REGARDING MANAGING DIRECTOR, DMRC

1. COMPANY PROFILE

DMRC, a joint venture company of Govt. of India and Govt. of National Capital Territory of Delhi, at par with Schedule 'A' Central PSUs has been set up for implementation and operations of rail based Mass Rapid Transit System in Delhi and other adjoining areas of NCR. The present metro network covers about 390 km. with 285 stations (including 28 interchange stations) spread across 12 lines and 15 depots. This includes the 29.16 km long Aqua Line of Noida Metro Rail Corporation (NMRC) and 12.85 km long Rapid Metro Corridor of Haryana Mass Rapid Transport Corporation. The passenger journeys stand at an average of approx. 6 million per day (pre covid). The Company has already commenced expanding the network of about 108 km under Phase-IV.

Besides construction and operation of Delhi Metro, the Company is providing consultancy services to other metro projects in the country as well as abroad.

Property Development, as part of Metro Constructions, and retailing in station premises is another major activity of the Company. The present revenue (Fare box and Non Fare box) is required to be scaled up. Foraying into International Consultancy Business in other countries is on the future agenda of the company.

The Company has set up very high standards in the implementation of mega infrastructure projects in a highly complex urban environment and is successfully operating the system for approximately 20 years.

The Company has a wholly owned subsidiary company with the objective to provide state of the art, dedicated, safe & secure, reliable, punctual, cost effective and environment friendly first & last mile connection to the metro commuters via e-buses, e-rickshaws, e-scooters, cycles, etc.

2. Job Description and Responsibilities

The Managing Director as the Chief Executive Officer will be responsible for overall functioning of the organization. He will be responsible for successful implementation of Delhi MRTS project within budget and time period. As the leader of approx. 14500 work force of Delhi Metro, he will be responsible for smooth operations of the Metro system. He will also be responsible for planning of expansion of Delhi MRTS project and should initiate timely action including preparation of DPR, tying up of funds and arranging Govt. approvals. He should run the metro operations with a vision of affordability of the services to the

common man yet ensuring sustainability of the system on its own. Further, he will be responsible for bringing Consultancy work including Project Management and execution work of other metro projects in India & abroad.

3. Eligibility

I. Age (Age of superannuation- 65 years)

Minimum - 45 years

*Maximum - 58 years- for external candidates

(* 60 years for internal candidates)

II. Qualification and Experience

The applicant should be an engineering graduate preferably from the civil or electrical engineering discipline with good academic record from a recognized university / institution. He should possess adequate experience at a senior level of management in a large organization of repute.

Persons with post-graduate qualifications in project management, MBA qualifications and having experience in implementing and operating rail based mass transit systems will have added advantage. Knowledge of planning, development, execution of metro projects or major rail based projects is desirable.

Applicants from government or public sector should have a minimum of 28 years of service in Group-A or equivalent executive grade.

Applicants from private sector should have a minimum of 5 years experience as CEO or a Director in an organization of repute and should have handled multi disciplinary engineering projects preferably in urban situations.

Government officers of the rank of Additional Secretary in Government of India or an equivalent scale with a brilliant track record of handling multi disciplinary rail based mass transit projects for at least 3 years will be eligible for consideration on immediate absorption basis.

4. Pay Scale

The pay scale of the post is ₹ 2,00,000-3,70,000/- (IDA) and other allowances/perks/privileges as applicable to the post of Managing Director as per DMRC's rules.

5. Age of Superannuation- 65 years

6. **Duration of appointment**

The appointment shall be for a period of 5 years or the date of superannuation, whichever is earlier.
