CIRCULAR

In compliance of Hon'ble Supreme Court order no.333 in IA No.316 in WP (C) No.13029/1985 competent authority has authorized vide Public Notice F.No.DC(ARU)/TPT/2011-12/1148 dated 08.08.2012 MLOs of Surajmal Vihar, Sarai Kale Khan and Raja Garden zones in addition to Auto Rickshaw Unit, Burari to grant registration/fitness and permit of new TSRs. The terms and condition of permit and eligibility criteria is mentioned in the public notice dated 08.08.2012 as enclosed herewith. To ensure compliance of above, following should be strictly adhered:-

- 1) The new TSR should be CNG fuelled model approved by the Transport Department, Govt. of NCT, Delhi.
- 2) The MLO shall ensure to verify the driving licence/PSV badge from the data available in the Transport Department to ascertain the eligibility.
- 3) MLO should also verify from MLO Headquarter, MLO Taxi Unit & MLO Auto Rikshaw Unit to ensure that the applicant do not possess any other transport vehicle or TSR in his name before grant of registration/fitness and permit.
- 4) MLO shall ensure that the electronic fare meter integrated with GPS/GRS device should be from manufacturers or suppliers having certification from DIMTS to ensure that GPS/GRS device integrated with fare meter is as per specification of the Command Control Centre established by the DIMTS and the electronic fare meter should be duly certified by the Controller, Weights and Measurement.
- 5) System Analyst shall ensure that software should automatically check the status of reservation quota status and preference to women applicant as stipulated in the above public notice.
- 6) The MLO shall ensure that proper arrangement of hardware and staff and requisite counters displaying the information for the applicants for fresh TSRs be made on priorities.

- 7) All MLOs should arrange requisite number of fitness certificates forms and any other form required under the rules as per format similar to Auto Rikshaw Unit, Burari for the sake of uniformity. DC (ARU) shall ensure to provide necessary assistance in this regard to the concerned MLOs.
- 8) DC(Ops.) shall issue necessary direction regarding constitution of Board of Inspectors in Zones Surajmal Vihar, Sarai Kale Khan and Raja Garden for issuance of registration/fitness and permit to TSR.
- 9) System Analyst shall assess software and hardware requirement in three zones, namely Surajmal Vihar, Sarai Kale Khan and Raja Garden to start functioning similar to ARU Unit, Burari for issuing registration/fitness and permits on receipt of requisition of concerned MLO.
- 10) MLOs Surajmal Vihar, Sarai Kale Khan and Raja Garden shall submit file relates to above through DC (Ops.).
- 11) Specimen of Form under rule-53 of DMVR-1993 is enclosed.
