**PUBLIC NOTICE**

**ATTENTION: OWNERS OF MORE THAN 10 YEARS OLD DIESEL AND MORE THAN 15 YEARS OLD PETROL VEHICLES IN DELHI**

1. Attention of general public is invited to the order of Hon'ble Supreme Court of India dated 29.10.2018 in the matter of W.P. (Civil) No. 13029/1985 titled - M/C. Mehta versus Union of India & Ors. wherein, in terms of Hon'ble National Green Tribunal order dated 7.4.2015, it was ordered that more than 10 years old diesel vehicles and more than 15 years old petrol vehicles shall not ply in NCR.

2. The Hon'ble Supreme Court of India in the above said case has also directed that the vehicles violating the orders will be impounded.

3. The general public is further informed that the validity of all category of vehicles in the Registration Certificates (RC) was shown as 15 years. But a diesel vehicle cannot ply in Delhi beyond 10 years in terms of the orders cited above. However, NOC can be obtained for diesel vehicle beyond 10 years but less than 15 years for states which have conveyed their concurrence for registration of such diesel vehicles. A list of such places is available on website of Transport Department.

4. Owners of such vehicles i.e. more than 10 year old diesel and more than 15 years old Petrol vehicles, are hereby **advised not to ply these vehicles**, on the roads in Delhi/NCR and further **advised to get such end of life vehicles scrapped** through the authorized scrappers of Transport Department, the list of which is available at the website of this Department ([www.https://transport.delhi.gov.in](https://transport.delhi.gov.in)). In absence of this, the vehicles are liable to be impounded and invite necessary penal action under Motor Vehicles Act, 1988.

In exercise of powers under Rule 115 (D) of Central Motor Vehicles Rules, 1989, Transport Department, GNCT of Delhi proposes to empanel Manufacturer/Supplier of approved Electric Retro-fitment kit, to convert the 10 years old Petrol and Diesel driven motor vehicles for Pure Electric Operation with retro-fitment of approved Pure Electric Propulsion. The Manufacturers / Suppliers of Electric Retro-fitment kits shall provide the information about the make and models of motor vehicles to which the Electric Propulsion Kit can be fitted and the range in kilometers available on single charge.

The application for empanelment may be submitted by the Manufacturers / Suppliers to the Deputy Commissioner (Operations - II), Room No. 104, First Floor, Transport Department, 5/9, Under Hill Road, Delhi - 110054, enclosing self attested copies of Type Approval Certificate/s along with annexures obtained from approved testing agencies in Rule-126 of CMVR, 1989 for the makes and models of petrol/diesel vehicles.
