Delhi, the 4th March, 2004

No.189/PA/SECY/STA/99/109 – In exercise of the powers conferred by clause (i) of Sub-section (1) of Section 67 of the Motor Vehicles Act, 1988 (59 of 1988), the Lieutenant Governor of the National Capital Territory of Delhi, having regard to clause (d) of the said Sub-section (1) hereby issues the following directions to the State Transport Authority of Delhi, namely:-

1. (a) The fares chargeable by the operators of stage carriage in the National Capital Territory of Delhi shall be as follows :-

| DISTANCE | FARE |
|------------------------------------|----------|
| Upto 4 Kilometers | Rs. 2.00 |
| From 4 to 8 Kilometers | Rs. 5.00 |
| From 8 to 12 Kilometers | Rs. 7.00 |
| From 12 to 16 Kilometers and above | Rs.10.00 |
| For Green Lines and LTDs of DTC | Rs.10.00 |

(b) There shall be no changes in pass charges of Delhi Transport Corporation and also there shall be no change in the levies imposed on the private operation vide earlier notification No.F.189/Secy/ STA/99/2832 dated 31-12-1999.

2. By virtue of rule 75 (2)(i) of the Delhi Motor Vehicles Rules, 1993 and the position of existing bus queue shelter (Bus Stands) and different road conditions such as cross section, position of traffic, lights, position of flyovers, position of sub-ways, position of important buildings, security reasons and other related issues, it would not be feasible for the crew of the stage carriage to take up or get down passengers exactly in terms of fare and distance combination as stipulated in Para 1 above, therefore the crew of the stage carriages and the permit holder shall ensure that the provisions of Rule 58 of the Delhi Motor Vehicles Rules, 1993 shall be made applicable to implement the fare distance combination as referred above in Para 1. In other words, all the stage carriages (both owned by the DTC and Private Operators) will, henceforth, charge fares on the basis of fare stages of route as approved by the State Transport Authority.

3. The route plan and the fare table as referred in Rule 58 of the Delhi Motor Vehicles Rules, 1993 shall be carried by the stage carriages and the fare table shall be displayed permanently inside stage carriages near entrance and exit gate. The fare table shall be painted on a plain surface in neat and clean manner.

No.7(31)/PA/SECY/STA/2000/409 – In exercise of the powers conferred by clause (i) of Sub-section (1) of Section 67 of the Motor Vehicles Act, 1988 (59 of 1988), the Lieutenant Governor of the National Capital Territory of Delhi, having regard to clause (d) of the said Sub-section (1) hereby issues the following directions to the State Transport Authority of Delhi, namely:-

The fares chargeable by the operators of the Taxis (Black & Yellow Top) in National Capital Territory of Delhi shall be as under :-

- (i) Taxis (Black & Yellow Top)= Rs.13/- for First kilometer (upon downing the meter) and thereafter Rs.7/-per Kilometer for every additional Kilometer.
- (ii) Night Charges = 25% of the fare (11.00 PM to 5.00AM)
- (iii) Waiting Charges = Rs.20/- per hour or part thereof (subject to minimum of 15 minutes stay).
- (iv) Luggage Charges = Rs.10/- per piece except for shopping bags or a small attaché case.
