Subject:- Motor Vehicles (Registration & Function of Vehicles Scrapping Facility) Rules - 2021-Reg.

Attention is drawn towards Circular No. F.DC/OPS/TPT/2021/330/ 075669790/973 dated 03-01-2023 issued by Transport Department, GNCT of Delhi whereby it has been informed that Scrapping Guidelines issued by Transport Department vide Order No. DC/OPS/TPT/11092017/3701-08 dated 24.08.2018 have become redundant and henceforth licences for scrappers will be issued as per Motor Vehicle (Registration and Function of Vehicle Scrapping Facility), Rules, 2021.

Accordingly, I am directed to inform all the Authorised Scrappers to whom licences were issued under Delhi Scrapping Guidelines, 2018 that their existing licences have become invalid and they are not authorised to conduct any activity related to scrapping.

Further, all the such authorised scrappers have option to either apply in the state where their scrapping yard/facilities are located or to apply afresh in Delhi under Motor Vehicles (Registration & Function of Vehicle Scrapping Facility) Rules-2021.

This has been issued with approval of competent authority.
