ORDER

Subject :- Implementation of Actions under Stage – III ('Severe' Air Quality) of revised GRAP in Delhi- NCR-steps to be taken

The Commission for Air Quality Management in NCR and adjoining areas, vide Direction No.83 dated 17th September,2024, issued statutory directions for implementation of the revised schedule of the Graded Response Action Plan (GRAP), available on the CAQM website (caqm.nic.in),as and when orders under GRAP are invoked.

The Sub-Committee constituted for invoking actions under the GRAP in its meeting held on 14th November, 2024 comprehensively reviewed the air quality scenario in the region as well as the forecasts for meteorological conditions and air quality index of Delhi made available by IMD/IITM and accordingly vide its order No.120017/27/GRAP/2021/CAQM 1092 DT 14th November, 2024 decided that ALL actions as envisaged under Stage III of the GRAP 'Severe' Air Quality (Delhi AQI ranging between 401-450) be implemented in right earnest by all the agencies concerned in the NCR, in addition to the Stage-I and II actions already in force, from 8:00 A.M. of 15th November, 2024 in the National Capital Region (NCR).

Accordingly, as per above directions and under Section 115 of Motor Vehicle Act, 1988, the following is hereby ordered during the imposition of GRAP Stage III 'Severe' Air Quality actions in addition to the Stage-I and II actions already in force, from 8:00 A.M. of 15th November, 2024 till 14th December 2024 or till downward revision in GRAP stage - III, whichever is earlier, in the National Capital Territory of Delhi :-

1. That there shall be no plying of BS III petrol and BS IV diesel LMV (4 wheelers) in Delhi.
2. That there shall no plying of Delhi – registered Diesel operated Medium Goods Vehicles (MGVs), of BS-III standards or below, in Delhi, except, those carrying essential commodities/ providing essential services.
3. The BS-III and below diesel operated LCVs (goods carriers) registered outside Delhi are not permitted to enter Delhi, except those carrying essential commodities/ providing essential services.
4. The Inter- State buses from NCR states other than EVs/CNG/BS-VI diesel are not permitted to enter Delhi (excluding buses / Tempo travellers operated with All India Tourist Permit).

Any violation of the above directions shall invite a prosecution under section 194(1) of Motor Vehicle Act, 1988 which provides a fine of Rs.20,000/-.

This issues with the approval of the Competent Authority.
