CIRCULAR REGARDING STATUS OF DE-REGISTERED DIESEL / PETROL VEHICLES

MoRTH has circulated draft notification, GSR 845(E) dated 24.11.2022, on scrapping of Government vehicles which are older than 15 years and creation of infrastructure to implement Voluntary - Vehicles Fleet Modernization Program (V-VMP) or Vehicle Scrapping Policy. Vide this draft notification it has been proposed that the Certificate of Registration of Govt. vehicles i.e. vehicles belonging to (i) Central Government and its Departments; (ii) State / UT Governments and their departments; (iii) Local Government Institutions, namely, the Municipal Corporations or Municipalities or Panchayats; (iv) State Transport Undertakings established under the Road Transport Corporation Act, 1950 (64 of 1950) and the Companies Act, 2013 (18 of 2013); (v) Public Undertakings; (vi) Autonomous bodies with the Central Government and State Governments shall not be renewed after the lapse of 15 years from the date of issue of such certificate. Disposal of such vehicles shall also be ensured through Registered Vehicle Scrapping Facility(RVSFs) set up in accordance with Motor Vehicle (Registration and Functions of Vehicle Scrapping Facility) Rules 2021. Final notification is slated for issuance in January 2023. Further, all condemned vehicles (including vehicles which have been prematurely condemned) are required to be scrapped through RVSFs. Ministry of Road Transport & Highway (MoRTH), Govt. of India vide notification GSR 653(E) dated 23.09.2021 has already notified the Motor Vehicle (Registration and Function of Vehicle Scrapping Facility) and GSR 695(E) dated 13.09.2022 Amendment Rules, 2022.

In case of NCT of Delhi, there is already a ban by Hon'ble NGT and Hon'ble Supreme Court of India on plying of 10 years old diesel vehicles and 15 years old petrol/CNG vehicles. Accordingly, Transport Department has already de-registered 53,78,514 diesel / petrol vehicles which had completed their life i.e. 10/15 years.

However, presently Transport Department is not having information regarding the fate of these vehicles whether they had been scrapped or have taken NOC from department. There

are around 80,000 vehicles out of the above de-registered vehicles which are owned by Central Government, State Government, Autonomous bodies and Govt. Undertakings.

In the above context, please find enclosed at Annexure-I O.M. dated 17th Dec'2022 circulated by Ministry of Road Transport and Highways regarding process of scrapping of Govt. Vehicles through MSTC via e-Auction process. Accordingly, All Organisations/Departments are directed to get 10 years old diesel vehicles and 15 years old petrol/CNG vehicles of your Organisations/Departments scrapped through MSTC via e-Auction in a time bound manner.

Additionally, All Organisations/Departments shall provide total number of vehicles which have been scrapped till 31st December'2022 and monthly plan for scrapping remaining vehicles as per table annexed at Annexure-II which would also include the details of such vehicles if any, owned by any PSU, Autonomous office/body or a committee etc. It may be ensured that these details are provided by 28th January'2023 at dcops05@gmail.com. A nodal officer also needs to be appointed by each department/organisation for the purpose and his details including name, designation, mobile no. and email address may also be furnished along with the requisite information by 28th January, 2023.

It has also been decided that all new purchases against scrapping, would only be of electric vehicles.

This issues with the approval of the Competent Authority.
