All conditions and compliance requirement, including validity, given in the certificate under reference are also applicable for the certificate.

Validity-This certificate valid up-to 14.11.2025 i.e. 3 years as per Extension of Validity certificate No. CAOA 0269 R01 dated 21.02.2023. Further, in accordance with TAC No. CJ5195 dated 29.06.2018, COP: CC0GR 9187 dated 01.07.2022, the pressure regulator (Type - **12 V Electronic**), Model Name- **Super**, manufactured by - **M/s Jiolat Fuel Tech Pvt. Ltd**, is allowed to be used with this CNG Kit, which is valid till **31.03.2024**.

The kit Manufacture/Supplier/Distributor is directed to ensure the strict compliance of CMV Rules 1989. The retrofitment should be carried out by the authorized workshops only. Further, approval is accorded subject to ensuring fitment of same components; parts/assemblies etc. details of which are given in the detailed specification duly endorsed by the M/s ICAT.

The Kit Manufacturer/installer must comply with **CAOA 0269** dated **15.11.2019** and also invariable enclose certified copy of specifications alongwith CNG installation certificate and specific layout plan of model approved by M/s ICAT.

DTOs/Registering Authorities shall at the time of endorsement of CNG fuel in registration certificate verify the CCoE approval of the CNG cylinder and cylinder Valve, in respect of make/identification number (as referred in Technical Specification of CNG system endorsed by ICAT) and documental reference for quantity/Sr. No. cleared by DoE, time to time. Further, it should also be ensured that the fitment of kit must be in accordance with the layout plan for fitment, terms & conditions and validity given in the Type Approval certificate subject to fulfilment of provision of Motor Vehicle Act, 1988 and Rules made there under the department instruction/order issued from time to time in this regard.

The endorsement of in-use vehicle will be done by Registering Authorities/DTOs only through the online software developed by NIC.
