
Validity - This certificate is valid until 31st March 2026.

Kit Manufacturer/Supplier/Distributor is directed to ensure the strict compliance of CMV Rule: 1989. The retrofitment should be carried out by the authorized workshops only. Further approval is accorded subject to ensuring fitment of same components, parts/assemblies etc. details of which are given in the detailed specification duly endorsed by the testing agency at the time of submission of vehicle for inspection/ endorsement of CNG in registration certificate.

All DTOs/Registering Authorities shall, at the time of endorsement of CNG fuel in registration certificate, verify the CCOE approval for the CNG cylinder and cylinder Valve, in respect of make/identification number (as referred in Technical Specification of CNG system endorsed by testing agency) and documental reference for quantity/Sr.No. Cleared by DoE, time to time. Further, should also be ensured that the fitment of kit must be in accordance with the layout plan for fitment, terms & condition and validity given in the type approval certificate subject fulfilment of provisions of Motor Vehicle Act, 1988 and Rules made there under and department instruction/ order issued from time to time in this regard.

The endorsement of CNG Fuel in RCs of in-use vehicle will be done by Register Authorities/DTOs only through the online software developed by NIC.
