The In-Use CNG converted base model "Wagon R LXI M BS4", when fitted with Catalytic Converter, meets Bharat Stage - IV norms. Same kit can therefore be fitted to "In-Use" base models given at "ANNEXURE-II", as they are within prescribed ± 25% cm³ range., i.e. between 1113.21 to 1280.79 cm³, manufactured /registered from 01st April 2013 to 31st March 2020, subject to specific approval, for layout plan by ICAT, for retrofitment of CNG Kit in each vehicle model.

Validity-This certificate is valid till validity of base model certificate No. CAQA 0796 dated 02.09.2021 or until further amendments in CMVR Rules, whichever is earlier. Further, in accordance with I-CAT TAC No. - CN9160 dated 27.05.2022 & CoP certificate No. CC0GT 8995 dated 28.03.2024 the CNG pressure regulator (Type - CNG Pressure Regulator), Model Name- "GG-01", is allowed to be used with this CNG Kit, which is valid till 31.03.2026.

All conditions and compliance requirements including validity, given in the certificate Issued for "In-Use" base model "Wagon R LXI M BS4 (998 cm3 - June 2013 make)" are also applicable for the MPFI, The details of "In-Use" Base Vehicle Models (14 numbers) approved by the Testing Agency with respect to this CNG Kit are given in Annexure-II fitted with Catalytic Converter for which LAYOUT PLAN, is enclosed at ANNEXURE-I.

Kit Manufacturer/Supplier/Distributor is directed to ensure the strict compliance of CMVR Rules 1989. The retrofitment should be carried out by the authorized workshops only. Further, approval is accorded subject to ensuring fitment of same components, parts/assemblies etc. details of which are given in the detailed specification duly endorsed by the M/s ICAT at the time of submission of vehicle for inspection/endorsement of CNG in registration certificate.

All DTOs/Registering Authority shall, at the time of endorsement of CNG fuel in registration certificate, verify, the CCoE approval for the CNG cylinder and cylinder Valve, in respect of make/identification number (as referred in Technical Specification of CNG system endorsed by M/s ICAT) and documental reference for quantity/Sr.No. Cleared by DoE, time to time. Further, it should also be ensured that the fitment of kit must be in accordance with the layout plan for fitment, terms & condition and validity given in the type approval certificate and the fitment receipt from the NIC online CNG module subject to fulfilment of provisions of Motor Vehicle Act, 1988 and Rules made there under and department instruction/order issued from time to time in this regard.

The endorsement of in-use vehicles will be done by Registering Authorities/DTOs only through the online software developed by NIC.
