In view of above, all DTOs are hereby directed to accept the above Base Model/variant "GLS 600 4MATIC Maybach" manufactured by M/s Mercedes-Benz AG DE-70372 Stuttgart under "Non Transport" category subject to compliance of the provisions of Motor Vehicles Act, 1988 and rules made thereunder, directions of Hon'ble Court /Tribunal and guidelines issued by the department from time to time, subject to production of vehicle for registration by the manufacturer / authorized dealer on following conditions:-

The authorized importer should enclose a certificate of origin and / or sales invoice issued by the original manufacturer in his name along with the Bill of Entry. These documents to be submitted at the time of registration to the registration authority.
