Registering Authorities shall, at the time of registration verify the PESO approval for the CNG cylinder and Cylinder Valve, in respect of make / identification no. (as referred in Point 3 & 4 of Technical Specifications of CNG system) and documental reference for Quantity/Sr. No. cleared by PESO, time to time.

In addition, compliance to Safety Checks, Requirements shall be verified by the designated authorities, as and whenever necessary based on the guidelines stipulated under Annexure-Iv of the above referred TAC dated 25/03/2023 (copy enclosed). The above said TAC is issued subject to the conditions as mentioned in said Annexure-IV.

The endorsement approval is accorded subject to the responsibility of the manufacturer for ensuring the fitment of the same components, parts/assemblies etc. The details which are given in the detailed specifications duly endorsed by **ICAT, Manesar, Gurugram** at the time of submission of the vehicles for COF/Registration Manufactured should ensure that the vehicle is delivered fully build by them and no element of local body is involved.

All DTOs/CMVI (Burari) are requested to accept the base model "**MARUTI SUPER CARRY STD CNG 1.2L 5MT**" and its variant(s) detailed above manufactured by **M/s Maruti Suzuki India Ltd**, in NCT of Delhi, subject to fulfillment of provisions of Motor Vehicle Act and Rules made there under directions of Hon'ble Court/ Tribunals, Ministry of Road Transport and Highways, Govt of India and the Department's instruction /order issued from time to time in this regard.
