## **CIRCULAR**

Transport Department issued circular No. F. SCOT(ARU & TU)/TPT/2023/C.D No.075742337/5590/75573 dated 14.08.2023, informing M /s Bajaj Auto Limited, B-60/61, Naraina Industrial Area, Phase-II, New Delhi-110028 that scrapping orders issued by Transport Department vide order No.DC(ARU)/TPT/378/2-11-12/569-73 dated 01.04.2014 have become redundant and directed that henceforth, the scrapping of Auto Rickshaws is discontinued at M/s Bajaj Auto Limited, 3-60/61, Naraina Industrial Area, Phase-II, New Delhi-110028.

Bajaj Auto Limited, E-60/61, Naraina Industrial Area, Phase-Il, New Delhi-110028 with prayer to allow the permit holders to get their vehicles scrapped at the above scarp centre for another 60 days as there is no scrapping centre in the state of Delhi registered under RVSF Rules-2021. It will be easy for the customers as they are not well verse with online process of filing for scrapping & all RVSF registered scrap centres are far off from Delhi.

In view of the above, the Competent Authority has permitted to M/s Bajaj Auto Limited, B-60/61, Naraina Industrial Area, Phase-II, New Delhi-110028 to scrap vehicles of permit holders **upto 30.09.2023**. Scrapping certificate issued beyond 30.09.2023 will not be considered valid in any case.

Further, the permit holder can also get their Vehicle Scrapped at any of the RVSF (Registration and Function of Vehicles Scrapping Facility) registered in any state. The link for list of RVSF is as under:
