Sub:- Directions for "No PUC Certificate" to vehicles without third registration mark in compliance to Hon'ble Supreme Court Order dated 27-01-2025 in W.P.(C) 13029/1985; regarding.

This has reference of above cited subject. In this regard the followings have been directed by worthy ACS (T)

"I believe that the Operation branch is already sending SMS of the same nature, being proposed by the PCD Branch, to those owners of vehicles not having third number plates. To implement the Supreme Court order, dated 27-01-2025, in letter and spirit, I direct the following:-

1. The SMS presently being issued by the Operation Branch, shall be suitably revised, also incorporating the direction that no PUC Certificate shall be issued to vehicles not affixed with third number plate.
2. It shall be explored (in association with IT Branch) how issuance of PUC through the software can be denied to vehicles not affixed with third number plate. Even if PUC gets issued, its updation on Vahan should be barred, if the third number plate is not updated in system.
3. ALL the PUC Centres shall be directed not to issue PUC Certificates to the vehicles found without third number plate.
4. Proposal for publicity of this order of the Supreme Court, through electronic and print media, shall be put up immediately".

ORDER

Directions for "No PUC Certificate" to vehicles without third registration Mark in compliance to Hon'ble Supreme Court Order dated 27-01-2025 in W.P.(C) 13029/1985.

All the PUC Centres of Delhi are hereby directed that with effective from 15-03-2025 no PUC Certificate shall be issued to any vehicle which does not has "Third Registration Mark" which is in the form of self- destructive type, chromium based hologram sticker affixed on the left-hand top side of the windshield of the vehicle. Please note that it is other than the "High Security Registration Plate" (HSRP) those are installed on the front and rear of the vehicle.

This order is in compliance to the directions/ order dated 27-01-2025 of the Hon'ble Supreme Court of India in W.P.(C) 13029/1985 and the Additional Chief Secretary Cum Commissioner (Transport), GNCT of Delhi to comply the same.

Any dereliction found will be viewed seriously and the PCC will be liable for action as prescribed under clause (3)(d)(iii) of rule of 99 of Delhi Motor Vehicles Rule, 1993 resulting suspension/cancellation.
