ORDER

Subject :- Implementation of Action under Stage – III ('Severe' air quality) of revised GRAP in Delhi NCR steps to be taken

The Sub-Committee for operationalisation of the revised GRAP has reviewed the air quality scenario as well as the forecasts for meteorological conditions and Air Quality Index, in Delhi. The Sub – Committee vide order No.120017/27/GRAP/2021/CAQM/11568-11707 dated 06th January 2023 has invoked all the actions as envisaged under **Stage – III** of the GRAP – 'Severe' Air Quality (Delhi AQI ranging between 401 – 450), with immediate effect in the NCR, with immediate effect, in addition to all the actions under Stage – I and Stage – II of the GRAP.

As per directions as provided under Stage – III of the revised GRAP and under Section 115 of Motor Vehicle Act, 1988, it is hereby ordered that there shall be restrictions to ply BS-III, Petrol and BS-IV, Diesel LMVs (4 Wheelers) in NCT of Delhi, with immediate effect, till dated 12.01.2023 or till downward revision in GRAP stage, whichever is earlier (*Except for vehicles deployed in Emergency Services, Police vehicles & Govt. vehicles used for Enforcement*)

If any BS-III, Petrol and BS-IV, Diesel LMV (4 wheeler) found plying on roads will be prosecuted under section 194(1) of Motor Vehicle Act, 1988 which provides a fine of Rs.20,000/-

This issues with the approval of the Competent Authority.
