CIRCULAR

Consequent upon the direction number 78 received from CAQM vide circular dated 19.10.2023 and subsequent circular of this office dated 26.10.2023 circulating the direction number 78 of CAQM for effective implementation, the said direction 78 has been clarified by the CAQM and read as under:-

"While the subject direction number 78 was issued only in the context of inter-state/inter-city public services being operated by the NCR State Governments, including State PSUs and private entities, it is hereby again clarified that these directions shall not be applicable to buses, tempo travellers, mini buses etc. under 'All India Tourist Vehicles (Permit)' serving to the tourism sector."

Therefore, the attention of all concerned are hereby invited to compliance the direction number 78 as per clarification made in respect of original direction of CAQM dated 19.10.2023. The said clarification may be considered in respect of this office circular no. TPT/AS/STA/Misc.-4/2021/075681535/98228/ dated 26.10.2023 without prejudice to the restrictions imposed under GRAP which are automatically applicable as & when situation arise.

"All India Tourist Permit" Diesel buses in Delhi - NCR.

Sir,

Vide the subject Direction, the Commission stipulated targeted timelines in respect of migration of all inter-city / inter-state bus services serving Delhi and other cities / towns in NCR to only EV/ CNG / BS-VI diesel.

- 2. Transport Department/ Traffic Police Department of GNCTD and all the NCR States were accordingly requested to widely disseminate these directions amongst all stakeholders and ensure strict compliance through regular monitoring of the field level implementation, including such inter-city/inter-state bus services being operated by State PSUs and private entities etc.
- 3. Various tourist operator association/ organisations have represented before the Commission that their bus services are also being dealt with by

- 4. They have further submitted that unlike point-to-point bus services, their operations are not restricted to Delhi/NCR but to all parts of the country, depending upon the tourist demand from various sectors and the bulk of operations for such buses are beyond the territory of NCR and have accordingly requested for permitting selective plying of BS-IV diesel "All India Tourist Permit" buses / tempo-travellers/ mini buses in Delhi-NCR, for providing services to tourists from across the country.
- 5.
