In view of above, all DTOs are hereby directed to accept the aforesaid models/variants manufactured by **M/s AUDI Co., Ltd.** under Non Transport category subject to compliance of the provisions of Motor Vehicles Act, 1988 and rules made thereunder, directions of Hon'ble Court /Tribunal and guidelines issued by the department from time to time, subject to production of vehicle for registration by the manufacturer / authorized dealer on following conditions:-

The authorized importer should enclose a certificate of origin and / or sales invoice issued by the original manufacturer in his name along with the Bill of Entry. These documents to be submitted at the time of registration to the registration authority.

1. Form No. 21 i.e. Sale Certificate and Local Sales Invoice should be issued by the authorized importer or dealer authorized by the importer having valid Trade Certificate.
2. The provisions in Rule 47 (h) of Central Motor Vehicle Rules, 1989 shall comply with.
3. This endorsement approval subject to fulfilment of provisions of Motor Vehicle Act and rules made there under, directions of Hon'ble Court /Tribunals, Ministry of Road Transport & Highways, Govt of India and department's instructions / order issued from time to time in this regard.
4.
