No. DTO/NZ/TPT/2024/6238 dated 04.02.2025 by the DTO, Mall Road, North Zone, Transport Department, GNCTD for Retention of Vehicle No. DL 2FAR 0999.


Present Mr. Rakesh Kumar, DTO Mall Road -North Zone and Ms. Sandhya Jain on 25.03.2025.

The DTO (Mall Road) has submitted that the application for retention was rejected as per the guidelines point to the fact that there was a delay in filing the retention application within 180 days from the untraced records after the said vehicle got stolen. Hence, the request of retention of registration number DL 2FAR 0999 was not considered.

The appellant stated that she was suffering from acute back pain during the period and being lady could not travel to Mall Road Authority from her current residence at South Extension Part-II. The appellant also submitted medical records dated 25.09.2024, along with affidavit stating the reasons for delay.


**ORDER**

This order shall dispose off an appeal filed under section 57 of Motor Vehicle Act, 1988 by SH. Ramesh Duggal, R/O 13A/20, W.E.A, Karol Bagh, New DELHI-110005 against the order No. DTO/NZ/Tpt./2025/7242 dated 11.02.2025 by the DTO, Mall Road, North Zone, Transport Department, GNCTD for Retention of Vehicle No. DL 3FAA0004.

Present Mr. Rakesh Kumar, DTO Mall Road -North Zone and Sh. Ramesh Duggal on 25.03.2025.

DTO Mall Road stated that the applicant got retention order on 31/01/2019. The vehicle was scrapped on 24/10/2020. He further stated that vide order dated 26/03/2020 direction were issued to get the vehicle scrapped by register/authorised scrapper of vehicles. His vehicle was not scrapped by authorised scrapper hence the retention was not allowed.


Applicant stated that as the period was peak of COVID pandemic he could not get to know of the aforementioned order of the Department. As the retention order was done in January 2019, and from March 2020, NCT of Delhi was in grip of COVID pandemic, benefit of doubt is given to appellatant. Retention of registration number DL3FAA 0004 is hereby allowed.
