ORDER

Whereas, a letter bearing no.13675-77 dated 26-12-2025 of the Asstt. Commissioner of Police Jaipur, forwarded to this office by District Transport Officer (South Zone), Delhi vide no. DTO/SZ/SKK/2026/6467 dt. 12-02-2026 has been received in this office on 24-02-2026.

Whereas, the Asstt. Commissioner of Police Jaipur vide its letter has informed that Sh. Sanjay Kumar S/o Sh. Suresh Kumar holder of Driving License No. DL03 19990215185 and driver of vehicle bearing registration no. DL10CV8469 is involved in Single Fatal Accident vide case FIR No. 317/25, U/S 281/106(1)BNS Police Station Bhankrota, Jaipur (West).

Whereas, the Asstt. Commissioner of Police Jaipur has requested for Suspension / Cancellation of Driving License no. DL03 19990215185 of Sh. Sanjay Kumar S/o Sh. Suresh Kumar.

Whereas, Sh. Sanjay Kumar S/o Sh. Suresh Kumar, holder of Driving License No. DL03 19990215185, involved in Single Fatal Accident vide case FIR No. 317/25, U/S 281/106(1)BNS Police Station Bhankrota, Jaipur (West), was given an opportunity vide this office Notice bearing no. DTO(HQ)/Tpt./1779 dt. 25.04.2026 with direction to appear before the undersigned and clarify his conduct under the principle of natural justice.

Whereas, Notice bearing no. DTO(HQ)/Tpt./1779 dt. 25.04.2026 has been returned back by the Postal Department with remark "left".

In view of above, the undersigned being the Licensing Authority under Sub Section 20 of Section 2 of Motor Vehicles Act, 1988 which conferred the powers to implement the provisions of Motor Vehicles Act, 1988 is satisfied that Sh. Sanjay Kumar S/o Sh. Suresh Kumar, holder of Driving License No. DL03 19990215185 has committed the Act which is likely to cause nuisance or danger to the public.

Therefore, Driving License No. DL03 19990215185 issued in the name of Sh. Sanjay Kumar S/o Sh. Suresh Kumar R/o 491, DDA Flat Lado Sarai, New Delhi-110030 is hereby disqualify for all category of vehicles mentioned in the said driving license under Section 19 (f) of Motor Vehicle Act, 1988 for a period of three months with immediate effect.
