CIRCULAR

The Competent Authority is pleased to endorse the Certificate No. **CARA 0679** dated **20th June 2022** issued by designated testing agency i.e M/s ICAT, Manesar, Gurgaon in respect of CNG kit identification "**WAGON SAE02**" and on the basis of layout plans submitted by the manufacturer/kit supplier/retrofitter, the M/s ICAT has certified that retrofitment of above CNG kit manufactured by **M/s SA ENGINEERS Old Ghass Mandi, Ambala City, Haryana- 134003**.

The testing agency certified that the above CNG converted "In-Use" Gasoline base model "**WAGON R LXI BS4**" (**July 2010 make**), Type & Category Passenger is Car & M1 respectively, fitted with O.E. Catalytic Converter meets the Bharat Stage-IV norms. Same kit can therefore, be fitted on the MPFI vehicle fitted with O.E. Catalytic Converter, between stipulated Engine cylinder capacity range (**748.5 to 1247.5 cm³**) manufacturer/registered from **01st April 2010 till 31st March 2013** (Bharat Stage-IV vehicle only) subject to specific approval, for layout plan by ICAT, for retrofitment of CNG Kit in each vehicle model.

The designated testing agency issued this certificate as per CMV rule 126, to establish compliance with the CMVR 1989 and those listed in **Annexure-I, IA & II**. Compliance to these rules has been verified by the testing agency based on the use of specific component, parts assemble etc. details of which are given in the detailed specifications duly endorsed by Testing Agency as given in detailed specification no. **SAE/H/WAGONR/T1 Dated 10.03.2022** mentioned in part 1a of this certificate. It is Kit Installer's responsibility to ensure fitment of same components/ parts / assemblies etc. before submission of the vehicle for registration.


Validity-This certificate valid up-to **19th June 2025** i.e. **3 years** from the date of issue of base type approval certificate **CARA 0679** dated **20th June 2022**. Further, the **validity of CNG Reducer/Pressure Regulator**, i.e. Model No. "**AB-200**", is accordance with I-CAT TAG/Reference no. **CM9389** dated **06.12.2022** is valid till **09.11.2024**.

The details of CNG Cylinder approved by the Testing Agency with respect to this CNG Kit are given in **Annexure-III**, the copy is Annexed herewith.

Kit Manufacture/Supplier/Distributor is directed to ensure the strict compliance of CMVR Rules 1989. The retro-fitment should be carried out by the authorized workshops only. Further, approval is accorded subject to ensuring fitment of same components, parts/assemblies etc. details of which are given in the detailed specification duly endorsed by the M/s ICAT at the time of submission of vehicle for inspection/endorsement of CNG in registration certificate.

All DTOs/Registering Authority shall, at the time of endorsement of CNG fuel in registration certificate, verify, the CCoE approval for the CNG cylinder and cylinder Valve, in respect of make/identification number (as referred in Technical Specification of CNG system endorsed by M/s ICAT) and documental reference for quantity/Sr.No. Cleared by DoE, time to time. Further, it should also be ensured that the fitment of kit must be in accordance with the layout plan for fitment, terms & condition and validity given in the type approval certificate and the fitment receipt from the NIC online CNG module subject to fulfillment of provisions of Motor Vehicle Act, 1988 and Rules made there under and department instruction/order issued from time to time in this regard.

The endorsement of in-use vehicle will be done by Registering Authorities/DTOs only through the online software developed by NIC.
