ORDER

Whereas the extension of additional one year had been granted in respect of RTV/Mini midi bus service over and above prescribed validity of permit, with the condition that said extension will not in any way affected the fitness conditions.

And whereas, while evaluating the effect of extension of permit, it has been observed that the RTV/Midi/Mini bus owners are not adhering to the condition of updating fitness. The reason behind not adhering to the permit extension conditions, it has been represented that, the RTV owners are still not recovered from financial loss incurred due to corona pandemic.

Whereas on assessing and considering difficulties/constraints being faced by RTV/Mini/Midi bus operators, the Principal Secretary- Cum- Commissioner Transport GNCTD, in order to grant further relief to RTV/Mini/Midi bus, has pleased to grant approval for exemption of payment of late fee/additional fee on delayed fitness under Rule 37A of Delhi Motor vehicle Rules 1993 and for delayed renewal of permit under sub rule 2 of Rule 60 of Delhi Motor Vehicle Rules 1993 in respect of RTV-Stage Carriage Midi buses upto 30/06/2022, failing which the late fee/penalty/additional fee will be charged from the date of expiry of permit/fitness certificate.

It is also clarified that above exemption of late fee/additional fee is only for those cases where fitness/permit expired after 01/02/2020 and any penalty/additional fee/ late fee already paid, shall not be refunded.

Any dereliction from avoiding the fitness of vehicles will dealt strictly under the provisions of law enforce for such matter.

This order shall be effective from the date of issue.
