The testing agency had certified that this Certificate is issued for the above In-Use vehicle model, subject to the following conditions:


1. The above "In-Use" vehicle model "**Hero Honda/Splender**" (March 1997 make), meets the requirements of GSR 629 (E) dated 24.06.2016. This pure electric system is permitted to be fitted on the in-use "Hero Honda/Splender" vehicles, manufactured/registered on and after 1st March 1997.
2. **This certificate is valid for the period of 3 years from the date of its issue** or until further amendment in CMV Rules, whichever is earlier or as per any specific directions from Ministry.
3. Any Change in the retrofitment system Specifications or Layout, will call for recertification.
4. The onus of verification of fitness / proper functioning of retrofitment system, on each and every vehicle, under this Certificate will be the responsibility of **M/s GoGo A1 Motors Pvt. Ltd.**

Kit Manufacture/Supplier/Distributor and Kit installer is/are directed to ensure the strict compliance of Central Motor Vehicle Rules, 1989. The retro-fitment should be carried out by the authorized workshops only. Further, approval is accorded subject to ensuring fitment of same components, parts/assemblies etc, details of which are given in the details specification duly endorsed by the **M/s ARAI, Pune** at the time of submission of vehicle for inspection/endorsement of Electric Kit in registration certificate.

The Kit Manufacturer/Installer must comply with Technical Specification of Electric Propulsion/conversion kit annexed to the **TAC No. AAQB 0284 dated 6th July, 2021.**

All DTO's/Registering Authority shall, at the time of endorsement of Electric fuel in registration certificate, verify all the component of Electric retro-fitment kit system endorsed by **M/s ARAI, Pune.** Further, it should also be ensured that the fitment of kit must be in accordance with the Type Approval Certificate issued by the testing agency and validity given in the type approval certificate, subject to fulfillment of provisions of Motor Vehicle Act, 1988 and rules made thereunder and department instruction/order issued from time to time in this regard.


