

ADDENDUM

In pursuance of the approval of the STA Board conveyed vide No.F.10(108)/AS/STA/TPT/2013/PF/34-43 dated 9th April, 2015 as resolution No.4/2015, the 'Permit Condition' notified vide even number dated 8th August, 2012 stands modified as follows -

- 1) **Clause 4** of the Permit Conditions shall stand amended to and read as under -
"The Auto Rickshaw permit would not be transferable for 5 years, except in case of death of permit holder as prescribed in section 82 of MV Act, 1988 and Rules framed thereunder. Thereafter the transfer to a person belonging to the same category can be considered. In case of legal heir of the deceased permit holder is minor, **widow, differently abled** and not having valid driving license & PSV badge can hire a driver having valid Driving License and badge issued by Transport Department, Delhi".
The above relaxation shall be subject to transfer of single vehicle and multiple permits will not be allowed; and
- 2) A **new clause** shall be inserted as **Clause 17** and shall read as under -
"In case of replacement of a TSR under the replacement policy notified vide F.No.DC(ARU)/Tpt./55/2011-12/1196-11984 dated 24.08.2012, the condition of possessing of Driving License & Public Service Badge as prescribed under condition 2 of the permit conditions approved by STA vide 8.8.2012 is relaxed in respect of a Senior Citizen (more than 60 years old) and Female owner of TSR."
The above relaxation shall be subject to replacement of single vehicle and multiple replacements will not be allowed.

The aforesaid permit conditions for issue of permits for Auto-rickshaws shall come into force with immediate effect.
