# After detailed deliberations, following decisions were taken in the meeting:-

 In collaboration with TRAX Road Safety NGO, in the meeting itself a power point presentation was displayed and issues and suggestive measures were discussed regarding Road Safety.

26/2/2021

- It was also decided to conduct a *BIKE RALLY & HELMET DISTRIBUTION* organized by DM Central and TRAX Road Safety NGO from Shahidi Park near FSK Fort, Delhi Gate, Delhi to DM Central Office, Darya Ganj, Delhi.
- 2. Updated identification of Black Spots: It was decided that the Traffic Police and Local Police (Central/North) and road owning agencies such as PWD, MCD, immediately shall provide updated list of identified black spots on the roads in the District Central. It was also discussed that while identifying the black spots certain criteria's are taken into consideration, such as road condition, area vulnerable for women safety, passenger volume and peak hour's congestion, diversions, engineering faults leading to accidents etc. faced at different points. On the basis of findings corrective measures may also be proposed to find possible solutions.

It was directed that all agencies must submit a requirement report regarding Road Safety to the O/o District Magistrate (Central).

[Action- DCP Traffic (Central Range), DCP (Central, North), MCD, PWD]

Deployment of Ambulances in District Central: - all the concerned agencies are directed
to assess the availability and approach time of ambulances in the district. CATS will provide
this statistical data in this regard.

[Action-CATS Deptt.]

4. Enforcement of Traffic Regulations: Traffic Police and Transport department are directed to provide their enforcement reports by 27.02.2021. Traffic Police must take corrective/punitive action with regard to illegal parking & submit ATR in this regard. Further Report should also be submitted by Traffic Police regarding deployment of Traffic Police personnel in accident prone/vulnerable areas & during peak hours. Loading Unloading not to be allowed during day time.

To identify accident prone areas in the district so that such area can be facilitated with safety measures.

[Action-DCP Traffic (Central Range) & MLOs]

To conduct campaign to spread awareness: - It was also decided that awareness session
to be organized regarding Road Safety in schools and Gender Resource Centres (GRC).
Traffic Police shall coordinate and DDE (North/Central) for such awareness sessions.

[Action- DCP Traffic (Central Range)]

Creation of wayside amenities: - It was decided that by 27.02.2021, PWD, MCD will
furnish list of public convenience available on roads. Further, they must also submit the
proposals under consideration regarding construction of public conveniences.

[Action-MCD and PWD]

7. The road owning agencies (MCD, PWD) and Traffic Police shall examine the areas where railings/footpaths/public convenience are required to be repaired, current status and requirement of blinkers/signage's/speed breakers near each schools & hospitals. The efforts must be made to cover all major schools & hospitals with appropriate signage's/blinkers/speed breakers to ensure smooth access & stop antisocial approach.

The maintenance activities of all street lights, footpaths, railings, signages, speed breakers etc. to be taken care on a serious note for public convenience and safety.

[Action- DCP Traffic (Central Range), MCD, PWD]

8. Transport Deptt. to provide with an ATR regarding the funds utilized for awareness sessions regarding Road Safety by 27.02.2021.

With reference to letter no. F.No.11/DC/NW/VIG./2014DRSC/542 dated 18/12/2019 regarding Notification of District Level Road Safety Committee, Regional Transport Officer (RTO)/Asst. Regional Transport Officer (ARTO), Transport Deptt. from District HQ is Member Secretary of District Level Road Safety Committee.

(Action: MLO's (IP Transport Authority, Sarai Kalen Khan Transport Authority, Mall Road Transport Authority, Burari Transport Authority,))

The recommendations of District Level Road Safety Committee are monitored by highest level and to take affective decision. It was reiterated that meeting should be attended by senior level officers to case out the process of decision making and implementation of decision taken in this meeting.
