A. Maintenance Of Street Lights

The J.E PWD (Electrical) informed the Chair that the tender had been awarded to vendor on 11.02.2021 for maintenance/replacement of street lights.

The Hon'ble Chairman directed to J.E PWD (Electrical) to complete the work in 02 months and submit report to the committee.

B. Joint Audit of vulnerable spots

The Hon'ble Chairman DRSC directed to PWD (Civil) and PWD (Electrical) and Traffic Police to conduct Joint Audit of vulnerable spots in district to find out remedial measures and submit report to the Committee.

(Action: PWD Civil, PWD Electrical and Traffic Police)

C. Awareness about road safety

The OSD to DDE I informed that different awareness programs are being organized in the schools of District by conducting Drawing competition, Essay competition, Slogan competition and special programs with traffic police from time to time.

The Hon'ble Chairman directed to increase the numbers of awareness programs in the schools of district and invite "Public Representatives" to motivate the children.

D. Trauma Center in district

The Addl. CDMO (NE) informed the Hon'ble Chairman that that District North East has no Trauma Center in its jurisdiction and in cases of road accident, patients are referred to GTB Hospital near to District North East

The Hon'ble Chairman DRSC directed that proposal for construction of Trauma Center in District should be sent to Secretary Health by Health Department of District.

E. Ambulance

The Addl.CDMO (N.E) informed the Chair that operational control of Ambulance is under the control of CATS.

It was also informed that residential areas in the district have narrow roads and high traffic jam therefore "Bike Ambulance" and "ECO Ambulance" are required in District.

In this regard Hon'ble Chairman directed to write letter to CATS to increase number of Ambulances in District.

The Hon'ble Chairman DRSC directed that senior officers of BSES, EDMC and Flood and Irrigation Departments to be present in the next meeting.


