

PLAN SCHEME FOR GRANT IN AID TO NGO'S FOR ROAD SAFETY FOR THE YEAR 2006-07.

For inviting applications from NGOs to provide GIA to promote road safety activities in Delhi, an advertisement was released by the Transport Deptt. on 23.8.06 in the leading local newspapers inviting applications from interested parties who fulfilled the following two approved criteria:-

- i. That the NGO should have been registered, under the Registration of Firm and Societies Act, 1860. and
- ii. That the NGO should have 2 years experience in road safety activities.

The last date for receipt of application was 14.9.06.

In response thereto, 199 applications were received. Of these two were received after the last date.

It was decided that eligible applicants be invited to interviews before a screening committee consisting of the following:-

The Screening Committee took note of the information received from the Planning Deptt. by its letter No. 21(24)/06-07/CDN/Plg./9269-82 dated 25.10.06 which contained the list of NGOs whose functioning were found dissatisfactory or were not functioning at all. The Committee decided that those applicants whose names appeared in the list furnished by the Planning Deptt., be not considered.

2. After scrutiny, it was observed that in all 149 NGOs were eligible for consideration. These applicants were invited for interviews/presentation on different dates, namely 20.1.07, 23.1.07, 25.1.07, 1.2.07, 3.2.07, 8.2.07 and 13.2.07. Of these only 140 applicants attended.

3. During these interviews , after interviewing all eligible applicants on different dates, the Screening Committee noted that there were NGOs, who had reflected in their accounts for 2005-06, the receipt of GIA for that year, but disbursed by the Tpt.Deptt. to them on 31st March, 06 with the express direction in individual sanction order to the effect that the amount be utilized in the

subsequent 6 months. The Committee was of the considered view that the statement of accounts etc. so presented was improper and therefore, unacceptable. The Committee, therefore, decided that their applications be not considered for GIA for 2006-07. Further, the Committee also decided that those NGOs who had not rendered accounts for 2005-06 along with their application be not considered.

4. Those, who appeared before the Screening Committee, were appraised on a variety of factors, but not limited to their past performance, whether in receipt of grant-in-aid from the deptt. or not, on the basis of the records produced and on the presentations made by the representatives present. The interviews covered the record of their activities in road safety awareness, types of instructional and informative material utilized and disseminated, balance sheets for the relevant years, the quality of trained and resource persons relied upon whether internally or externally, the quality and contents of annual reports, if any, presented, and any

other material relied upon by the NGO concerned to project the kind of activity undertaken, and the potential impact.

5. It was also decided that as in the past, the performance of each of the NGO be graded by discussion and consensus as "A" (Outstanding), "B" (Very good) , "C"(Good) ,"D"(Satisfactory) and "E". It decided that NGOs, getting "E" grade, are not to be considered for Grant-in-Aid.

6. The recommendations of the Screening Committee for grant-in-aid to the NGOs, who were awarded grades from categories A to D and the amounts thereon have received the approval of the competent authority for disbursement. The list of NGOs and the amount awarded to each is given herein below:-

Of the 71 NGO's listed above, 30 are those who have not been granted assistance under this scheme in last year but granted assistance this year.

It may be noted that NGOs, by and large, have been informed that the activity for the year is to be undertaken in a focused manner, either by way of promoting a specific road safety activity e.g. health check-up, adopting specific traffic intersections, or specific target group in the transport sector e.g. auto-rickshaws/cycle-rickshaws, use of pedestrians facilities at crowded intersections, subways, over-bridges, zebra crossings etc., disciplined parking and movement of traffic on congested intersections/ market places etc. Moreover, the Zonal Motor Licensing Officers will also monitor the activities of these NGOs.
