1. The State Transport Authority, Govt. of NCT of Delhi under the relevant provisions of Motor Vehicles Act, 1988 has attached further condition to the permit of CNG propelled Stage and Contract Carriage Omni Bus.

ORDER

In order to safety of the commuters and other road users, the permit holders and drivers of the Compressed Natural Gas propelled Omni Buses, having stage and contract carriage permits shall ensure that the Omni Bus under their control and undergo quarterly safety checks at any of the centers of Delhi Transport Corporation, approved by the Commissioner, Transport Department, Govt. of NCT of Delhi and shall also hold a certificate as approved by Commissioner, Transport Department, Govt. of NCT of Delhi to this effect, issued by the competent authority as approved by Commissioner, Transport Department, Govt. of NCT of Delhi and the driver of the motor vehicle in any public place shall on demand produce the certificate for examination.

- 2. The permit condition has come into force with effect from 15.02.2006.
- 3. Certificate of fitness issued by Inspection Unit, Burari shall also be considered valid document to satisfy the requirement of CNG leakage certificate for 3 months from the date of issue. Deputy Commissioner (Burari) shall accordingly made suitable inscription on the existing format of Certificate of Fitness.
- 4. The permit holder shall produce "No CNG Leakage Certificate" issued by the DTC/IU, Burari, as the case may be in the Enforcement Branch for obtaining the clearance certificate in this regard and the same shall be submitted to the IU, Burari to enable them to allow the vehicle for inspection/fitness thereof. Enforcement Branch shall depute competent officer to issue clearance certificate.

- 5. Those CNG propelled buses, which do not have such certificate, shall not be subjected to fitness at Vehicle Inspection Unit, Burari at all. In such cases where the permit holder had not obtained no leakage certificate(s) from DTC for each quarter prior to the date when the renewal is due in respect of the fitness certificate at Burari, the Enforcement Wing of Transport Department at 5/9, Under Hill Road, Delhi 110054, shall prepare a challan for contravention of the permit condition and take action as per the law and shall issue challan clearance certificate regarding CNG leakage also to the permit holder in the same manner as is done at present.
- 6. This issues with the approval of Chairman, State Transport Authority/ Secretary-cum-Commissioner, Transport.
