Release of this amount is subject to the following conditions:

- 1. The sanctioned 'Grant-in-Aid' has to be utilized by the NGO within six month of release in taking up activities relating to road safety.
- 2. The NGO will keep the Transport Deptt. informed about different road safety activities to be taken up by it.

- 3. It will keep up to date record of the activities and the account thereof including dates of each programme, name and age of the beneficiaries, special aids like spectacles etc. it distributed.
- 4. To make the account relating to Grant-in-Aid available for inspection of the deptt. and also of the Local fund examiner of Govt. of Delhi.
- 5. Not more than 30% of the Grant-in-Aid can be utilized for salaries, office expenses etc.
- 6. Execution of Bond and submission of detailed time bound programme for utilization of funds by the concerned NGO within a week of issue of the sanction/cheque.
- 7. Release of grant-in-Aid, in future, will be subject to proper utilization of the funds released, as per activities assigned, on production of accounts and "Utilisation Certificate".
