## PUBLIC NOTICE

## (Notice for Applicants in the matter of Rajeev Kumar VS GNCTD, WP(C) No. 2443/ 2016 and similarly placed persons)

## (10,000 AUTO RICKSHAW PERMITS SCHEME)

- 1. This is for information the petitioners and the other persons similarly placed in the matter of Rajeev Kumar Vs GNCTD which was heard by the Hon'ble high Court on 09.08.2017 and the Hon'ble Court directed to process the applications of the petitioners and the other persons similarly placed, which are 324, within 3 weeks from 09.08.2017, and directed that in any eventuality, the entire process in terms of the order dated 18.05.2017 shall be completed within 2 months from 09.08.2017.
- 2. Earlier, during the hearing of this case on 19.12.2016, it was agreed between the parties that GNCTD shall initiate the process of inviting applications for issuance of fresh 10,000 TSR permitsand the petitioners as well as those who had been issued LOIs in 2015 shall also be entitled to participate in the fresh process.
- 3. As per the policy, the list of 11,177 applicants in order of seniority of driving license of TSR has been published on the website of transport department. Further, the applicant should have never been allotted a TSR permit by the Transport Department.
- 4. In order to comply with the court orders within the time period of three weeks from 09.08.2017, the petitioners and the other persons similarly placed, who are eligible in the list of first 11,177 applicants and not in possession of any TSR / Commercial permit and never allotted a TSR permit , are directed to submit the prescribed documents for consideration of registration of new TSRs from 14.08.2017 to 18.08.2017 between 10.00 AM to 1.00 PM in the office of MLO (ARID), Burari as per given schedule above:
  - a. Online generated application form duly signed by the applicant
  - b. Copy of valid TSR driving license.
  - c. Copy of valid TSR PSV badge.
  - d. Copy of Aadhaar Card
  - e. 2 photographs
  - f. Address proof
  - g. Copy of indemnity bond.
- 5. An indemnity bond should be furnished by the applicant regarding non-possession of any other Transport Vehicle permit in the name of the applicant and also to the effect that the applicant has never held any TSR permit originally allotted by the Transport Department, which if found wrong, the LOI/permit/TSR registrations shall be cancelled at any stage and the action under various provisions of the IPC shall also be taken against the applicant.
- 6. In order to comply the court orders within three weeks, the above-mentioned applicants are further directed to submit the application as per the above given schedule. If the petitioners and the other persons similarly placed, fail to submit the application with the prescribed documents within the given time frame then it will be assumed that they are not interested in getting the LOU TSR permit and therefore, their application will be rejected.
- 7. This is to further inform the petitioners and the other persons similarly placed, that the list of 11,177 applicants will be checked again as per revised condition and if it is found that the petitioners and the other persons similarly placed, are covered in the revised eligibility list, then their applications will be considered again in the second round.
