

Further, it should also be ensured that the fitment of kit must be in accordance with the layout plan for fitment, terms & conditions and validity given in the Type Approval certificate subject to fulfillment of provision of Motor Vehicle Act, 1988 and Rules made there under the department instruction/order issued from time to time in this regard.
