Recently, certain directions were issued by the State Transport Authority regarding removal of Curtains and Tinted Glasses/Films from all the Public Service Vehicles. Though compliance with such instruction would not have taken more than few hours; yet it has come to notice that few owners of Contract Carriage Buses have refused to provide buses to Schools on the plea that removal of curtains and tinted films would take time. State Transport Authority, Government of NCT of Delhi has taken a very serious view of this conduct as an attempt to defy orders of STA and putting public/school children to inconvenience in the present severe cold conditions.

In view of above, STA has decided to cancel permits of all such buses forthwith and not to grant any category of Permits to them in future. Accordingly, all the school authorities are requested to provide details of all such contract carriage buses that are not being provided for ferrying of school children despite their existing agreements, to enable STA to take strict action in the matter. Further, all the owners of Contract Carriage Buses are advised to provide buses to school in accordance with their existing agreements, to avoid any action from STA.
